NAVIGATION OF THE WEBSITE

To ensure the proper functioning of this site.

CATEGORIES OF DATA: IP addresses, domain names, URIs. These data are acquired by the computer systems responsible for the operation of the web page.

LEGAL BASIS: The need to provide the necessary services to enable navigation on this site and our Legitimate Interest in ensuring the proper functioning of the computer systems.

RETENTION PERIOD: 30 days, unless the law and the provisions of Public Authorities provide otherwise for the ascertainment of cyber crimes.

CATEGORIES OF DATA: Data requested in the contact form and contained in the information request.

LEGAL BASIS: The execution of pre-contractual measures taken at your request.

RETENTION PERIOD: Until you revoke your consent.

COOKIE

Cookies are small text files saved on your device that make the use of the site smoother and simpler, ensuring, for example, the enjoyment of video content.

CATEGORIES OF COOKIES:

DISCLOSING, SHARING AND TRANSFER OF YOUR DATA

Your data are not disclosed but are communicated to the staff and suppliers of Cantiere del Pardo (e.g., service providers, IT platforms, or consultants). Additionally, if necessary and required by law, your data will be disclosed to public authorities upon their request.

Your data may be transferred outside the EU; however, this will always be done in compliance with the guarantees and safeguards provided by the regulations on personal data.

YOUR PRIVACY RIGHTS

The GDPR grants you certain rights regarding your personal data which you can exercise by writing to data.protection@calzedonia.com. You will receive a response as soon as possible and, in any case, within 30 days. You may need to provide additional information if, in relation to your request, it is necessary to verify your identity.

RIGHT OF ACCESS

You have the right to know if your data is being processed and, if so, to obtain a copy of such data. You also have the right to be informed about: the origin of the data, the categories of personal data processed, the recipients of the data, the purposes of the processing, the existence of automated decision-making (including profiling), the data retention period, and the rights granted to you under the GDPR.

RIGHT TO ERASURE

You have the right to request that your data be deleted if it is no longer needed or if the Controller is no longer authorized to process them.

RIGHT TO PORTABILITY

You have the right to receive your personal data in a structured, commonly used, and machine-readable format; you also have the right to request that such data be transmitted to another Controller.

RIGHT TO OBJECT

You have the right to object to the use of your data processed under the legitimate interest of the Controller.

RIGHT TO RECTIFICATION

You have the right to obtain rectification or integration if your data is inaccurate or incomplete.

RIGHT TO RESTRICTION OF PROCESSING

You have the right to obtain the restriction of processing when you have contested the accuracy of personal data, for the period during which the Data Controller carries out verifications; Data Controller is not authorized to process your data and, instead of requesting their deletion, you can request to limit their use; if the data Data Controller holds - even if they are no longer necessary for the purposes of the processing for which they were collected - are necessary for you to establish, exercise, or defend a legal claim.

RIGHT TO WITHDRAW THE CONSENT

You have the right to withdraw your consent at any time for processing based on it.

Additionally, if you believe that the processing of your personal data concerning you is carried out in violation of the provisions of the GDPR, you have the **RIGHT TO LODGE A COMPLAINT** with the supervisory authority.
